#### **Question 3**

Madam Speaker would the Premier and Minister of Finance please tell this Honourable House what measures, if any, are in place to strengthen border security and prevent illegal immigration, trafficking, and the smuggling of contraband into the country?

#### **Question 4**

Madam Speaker would the Premier and Minister of Finance please tell this Honourable House if there are measures in place addressing cybersecurity challenges and protecting critical infrastructure and sensitive data from cyber threats and attacks?

Madam Speaker would the Premier and Minister of Finance please tell this Honourable House if there are any regulatory framework that governs private security services within the country, and how does the government oversee and ensure compliance with relevant laws and standards?

Madam Speaker would the Deputy Premier and Minister for Financial Services, Labour and Trade tell this Honourable House, in light of a not so good report from the CFATF, how is the government monitoring and safeguarding the stability of the financial sector in the British Virgin Islands to mitigate risks, prevent financial crimes, and promote trust in the jurisdiction as a reputable Financial Services Centre?

#### **Question 3**

Madam Speaker would the Deputy Premier and Minister for Financial Services, Labour and Trade inform this Honourable House what strategies, if any, are being implemented to promote financial inclusion and access to banking services for all residents in the British Virgin Islands, particularly marginalized or underserved communities?

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House what specific measures are being taken to ensure that non-profit organizations receive adequate resources and support to effectively complement the efforts of the healthcare system?

Madam Speaker would the Honourable Minister for Health and Social Development please share with this Honourable House any successful examples of collaboration between the government health agencies and non-profit organizations that have significantly impacted healthcare delivery and patient outcomes?

#### **Question 5**

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House what steps are the government taking to promote greater coordination and cooperation between non-profit organizations, healthcare providers, and government agencies to address complex health and social development issues?

#### **Question 6**

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House how does the ministry ensure transparency and accountability in the distribution of funds and resources to non-profit organizations involved in healthcare and social support services?

#### **Question 7**

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House in what ways are non-profit organizations involved in health-related research, advocacy, and policy development, and how does the ministry support and leverage their expertise in these areas?

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House how does the government plan to expand and strengthen partnerships with non-profit organizations to address emerging health and social challenges and adapt to the changing needs of the population?

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House what role do non-profit organizations play in promoting community engagement, public health awareness, and preventive healthcare initiatives, and how is the government collaborating with them in these areas?

Madam Speaker would the Honourable Minister for Health and Social Development please tell this Honourable House how does the Ministry plan to measure the impact and assess the outcomes of the collaborative efforts between non-profit organizations and the government in the Health and Social Development sectors?

## iv) The Deputy Speaker and Territorial Member to ask the Honourable Premier and Minister of Finance the following questions:

Madam Speaker, since getting elected it has been brought to my attention that vessels operated by Chinese fishermen have been dragging nets in the waters off of Anegada, many of which have washed up on our shores. Could the Honourable Premier and Minister responsible for fisheries, please tell this Honourable House whether he is aware of this situation and what steps have the Government taken to address this concern? Has there been any seizures of boats or crew concerning this illegal activity?

#### **Question 2**

Madam Speaker, could the Premier and Minister of Finance inform this honourable house of the following:

- a) Does the transition to the new salaries have an immediate effect on existing officers on contract?
- b) If yes, why would the new salaries not take effect upon negotiations of new contractual terms?
- c) How many public officers under contractual terms would have these adjustments within their existing contracts, and at what grade levels are these public officers' posts classified?

#### **Question 3**

Madam Speaker, in the press conference on March 15, 2024, the Premier and Minister of Finance, indicated Cabinet approval for hiring the Governance Reform Delivery Manager. Could the Honourable Premier please tell this Honourable House:

- a) If this post was advertised? If not, could he indicate the selection criteria applied for identifying prospective candidates?
  - i) How many candidates were shortlisted?
  - ii) What is the anticipated term of engagement?

- b) Could the Premier please provide a job description for the new post and outline the deliverables?
- c) Identify how the duties of this post differ from those of the current coordinator? and
- d) Are these two (2) posts expected to exist simultaneously?
- v) The Deputy Speaker and Territorial Member to ask the Honourable Deputy Premier and Minister for Financial Services, Labour and Trade the following question:

Madam Speaker, could the Honourable Deputy Premier and Minister for Financial Services, Trade and Labour, please inform this Honourable House of the progress, if any, with the development and implementation of the policy for grant assistance for small businesses in the Territory? If there is no progress as yet, then when does the Deputy Premier expect to have a substantial update?

vi) The Deputy Speaker and Territorial Member to ask the Honourable Minister for Communications and Works the following question:

#### **Question 1**

Madam Speaker, as you drive around the Territory, it can be noted that some places are not well lit in the evenings such as the Brandywine Bay area. Could the Honourable Minister for Communications and Works please inform this Honourable House if the ministry has identified any areas across the Territory that they will be improving? If yes, could the Minister please provide this Honourable House with a list of areas and dates when works will commence?

vii) The Deputy Speaker and Territorial Member to ask the Honourable Minister for Health and Social Development the following questions:

#### **Question 1**

Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House the status of the youth courts in the Territory and give a summary of statistics including types of crimes, frequency of those crimes, ages and numbers of youth charged?

Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House, if the National Drug Advisory Council is in place? If yes, please state the names of the members. If not, please give a date when this board will be commissioned.

## viii) The Deputy Speaker and Territorial Member to ask the Honourable Minister for Education, Youth Affairs and Sports the following questions:

#### **Question 1**

Madam Speaker, there continues to exist a number of citizens in this Territory who are interested in the legislation and promotion of drag racing. In years, prior studies were done on the feasibility of promoting this sport and the tourism impact it would have. Could the Honourable Minister for Education, Youth Affairs and Sports please provide this Honourable House with an update on the status of this industry and has the Government made any progress forward?

#### **Question 2**

Madam Speaker, just after the elections in 2023, the ministry announced territory-wide after-school programmes. Could the Honourable Minister for Education, Youth Affairs and Sports please tell this Honourable House:

- a) The methods used for assessing the programmes' success?
- b) What changes have been made, if any, to the programmes offered, duration, number of schools engaged and enrolment numbers for each location? and
- c) How much money has been spent to date on salaries and resources per school?

## ix) The Member for the Third District to ask the Honourable Premier and Minister of Finance the following questions:

#### **Question 1**

Madam Speaker, could the Honourable Premier and Minister of Finance please tell this Honourable House whether his government acknowledges spear fishing, commercial or otherwise in the Virgin Islands as legitimate?

a) If the answer is yes, could he quote for this Honourable House the section of law under which it is authorized and clearly state which type of fishing it prescribes?

b) If the answer is no, could he tell this Honourable House whether any efforts are being made by his administration to accommodate spear fishing, especially commercial, in the Virgin Islands?

#### **Question 2**

Similarly, as it relates to question number one Madam Speaker, can the Honourable Premier and Minister of Finance please tell this Honourable House whether his government acknowledges spear fishing aided with SCUBA, commercial or otherwise in the Virgin Islands as legitimate?

- a) If the answer is yes, could you quote for this Honourable House the section law under which it is authorized and clearly state which type of fishing it prescribes?
- b) If the answer is no, could you tell this Honourable House whether any efforts are being made by your administration to accommodate spear fishing with SCUBA, especially commercial in the Virgin Islands?

#### **Question 3**

Madam Speaker, given the massive sums of money needed to provide adequately for our Health Care, Education, and Infrastructure: particularly Water and Roads, and given that the 2024 Budget does not address these needs; could the Honourable Premier and Minister of Finance please tell this Honourable House whether:

- a) It is his intention to address these matters during the lifetime of this administration? And
- b) If his answer is yes Madam Speaker, could he give this Honourable House the outline of his plan with a schedule indicating timelines for his action?

#### **Question 4**

Madam Speaker, the Honourable Premier and others in this and last Administration has been feeding us an incredible narrative without evidence, about the \$426 million loan guaranty the British government offered the Territory as a means to restore the Territory to pre-Irma conditions. Madam Speaker, could the Honourable Premier and Minister of Finance please tell this Honourable House whether:

- a) This offer is no longer on the table?
  - i. If the answer is yes, can he provide this Honourable House with the correspondence from the British to that effect?

- ii. If the answer is no, can he tell this House if he is going to take the British up on their offer? And
- b) He agrees that it is time we bring the whole matter of this Loan guarantee to an end by being honest to the people and telling whole story?

Madam Speaker, will the Honourable Premier and Minister of Finance agree that we cannot claim pre-Irma restoration has been achieved until we have achieved among others:

- a) Rebuilding the Grandstand and Stables at Ellis Thomas Downs, which are all on Crown property, by the way?
- b) Removing the derelict yachts/boats from the Sea Cows Bay Harbour?
- c) Recommissioning the Burt Point Sewage Treatment Plant? and
- d) Realigning all of Drake's Highway from Fort Burt to Fort Recovery?

#### **Question 6**

Madam Speaker, could the Honourable Premier and Minister of Finance please share with this Honourable House his options for borrowing, to restore the Territory to pre Irma's conditions, besides the \$426 million loan guarantee by the British Government?

x) The Member for the Third District to ask the Honourable Minister for Communications and Works the following questions:

#### **Question 1**

Madam Speaker, water is being rationed on a daily basis, to the cries of many residents especially my constituents in the 3rd District. Could the Minister for Communications and Works:

- a) Please tell this Honourable House why he tolerates this inability to execute the task to deliver by his department? and
- b) Could he please tell this Honourable House the reasons for such inabilities?

Madam Speaker, the Government is obligated to pay Seven Seas for 2.3 million gallons of water each day, whether government takes the water or not, provided the water is produced, or if there is a failure in production due to a fault of the Government. Could the Minister for Communications and Works please tell this Honourable House:

- a) How much money have we paid to Seven Seas for the year 2023 giving the months and the dates, for water we did not take daily, that is the quantity between what we took and the 2.3 million gallons? And
- b) Give the reasons on each occasion for not taking the full 2.3 million gallons of water?

#### **Question 3**

Madam Speaker, in response to a question submitted to this Honourable House on June 29th, at the 5th Sitting of this Honourable House, the Honourable Minister for Communications and Works acknowledged familiarity with the poor conditions of the main road in Sea Cows Bay, especially in the area of De La Santa Bakery, and gave assurance that the poor conditions would be remedied. Madam Speaker, some patching was done since, but it is currently as bad now, or worse than it was then.

- a) Could the Minister please tell this Honourable House why this condition is allowed to persist? and
- b) Could he give a date for a substantial fix that is permanent in nature?

#### **Question 4**

Madam Speaker, in the 2024 Budget each District was given access to a small allocation for Civil Mitigation works, such as road and drainage works among others. Could the Honourable Minister for Communications and Works please tell this Honourable House:

- a) How much of that allocated for the 3rd District has been spent to date?
- b) What projects was the money spent on, giving a description? and
- c) How much was the allocation?

Madam Speaker, with regards to the 2023 Civil Mitigation vote of \$250,000 for District 3, could the Honourable Minister for Communications and Works please tell this Honourable House:

- a) How much of the \$250,000 allocated for the 3rd District was spent on projects completed in 2022? and
- b) Why weren't those projects charged to the 2022 Civil Mitigation Vote?

#### **Question 6**

Madam Speaker, with regards to the moneys allocated to each District as stipulated in Question No. 4, could the Honourable Minister for Communications and Works please tell this Honourable House:

- a) How much money was spent in each of the 9 Districts for 2023? and
- b) How much of the money used from the said allocation was for work in 2022, or for any year except 2023?

#### **Question 7**

Madam Speaker, on Sunday, March 17th my constituents reported not getting water for three (3) days - that's since Thursday 14<sup>th</sup>. Upon enquiry, I learned that there was an intake main break to the reservoir, and that priority repairs were promised for Monday 18th, however, even if successful, residents should not expect water for at least a few more days, due to the curing time necessary. Madam Speaker, could Honourable Minister for Communications and Works please tell this Honourable House:

- a) Why would a situation like this be allowed to go on for three (3) days before a scheduled attempt to be fixed?
- b) How many repair crews does the Department have? and
- c) Is there a dedicated crew for evening and weekend emergencies?

#### **Question 8**

Madam Speaker, could the Honourable Minister for Communications and Works please tell this Honourable House:

a) The means by which water is conveyed from the Sabbath Hill reservoir to the

Fort Hill reservoir? and

b) When was that infrastructure used to convey the water put in place?

#### **Question 9**

Madam Speaker, could the Honourable Minister for Communications and Works please tell this Honourable House:

- a) How far west does the Fort Hill reservoir currently serve? and
- b) How far west could it realistically serve with effectiveness.

## xi) The Member for the Third District to ask the Honourable Minister for Health and Social Development the following questions:

#### **Question 1**

Madam Speaker, upon the request of Honourable Members during Standing Finance for a special session with the BVIHSA and NHI to ascertain how what seemed to be some crucial miscommunications between the two (2) entities could be worked out, could the Honourable Minister for Health and Social Development please tell this Honourable House whether the two (2) bodies have met, and how many times?

#### **Question 2**

Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House:

- a) Why does central government give NHI \$41 million to be further disbursed to the BVIHSA and not give the money directly to BVIHSA?
- b) What exactly is the money for? and
- c) Could the Minister please present this House with the Policy outlining how the money is to be disbursed?

#### **Question 3**

Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House:

a) How much of the \$41 million given to NHI since 2019 was transferred to BVIHSA each year? And

- b) If at any time did NHI not transfer the full amount,
  - a. How much was withheld?
  - b. Why?

Madam Speaker, a few weeks ago I called the Honourable Minister to report a complaint I received about the MRI at the hospital being out of commission due to a broken Air Conditioning system. To which he confirmed. Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House:

- b) Is the MRI now functioning and accessible to residents? And
- c) When did this problem started, and when did it end?

#### **Question 5**

Madam Speaker, if my memory serves me correct, the CEO of the BVIHS is the Chief of Medical Staff in an acting capacity, or someone else who is not confirmed to the post. Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House:

- a) Whether the CEO position at BVIHSA is being held in an acting capacity?
  - a. If yes, who is in the position and why?
  - b. If no, who is in the position and when was the post filled? and
  - c. How long has the substantive post been unfilled?

#### **Question 6**

Madam Speaker, I note with interest that the patient rooms in the hospital no longer have a basic commodity which the authorities thought was worth having when it was dedicated. Madam Speaker, could the Honourable Minister for Health and Social Development please tell this Honourable House:

- c) Is this a permanent decision?

More specifically will the Minister state whether it's the Government's intention to comply with the initiative before the 2025 deadline and what efforts, if any, have been made to sensitize the BVI populace of the potential ramifications of this initiative?

#### **Question 2**

Madam Speaker, the Government recently announced the repurposing of the Old CTL Building to house the Magistrates Court, could the Honourable Premier and Minister of Finance please inform this Honourable House and the people of these Virgin Islands what plans, if any, his Government has for repurposing the Old Government Administration on Main Street? Will the Minister agree that this building is of immense cultural and historical value to the Territory and that leaving it fallow in its current dilapidated and deteriorating state would be a national travesty when there are so many critical public purposes for which it can be rehabilitated?

Madam Speaker, could the Honourable Premier and Minister of Finance please tell this Honourable House what was done with the plane that was ceased during a recent drug smuggling operation over on Anegada?
